## Directions For Use:

Read the entire label before using Vireo MEC. Apply Vireo MEC with ground equipment, using sufficient spray volume to provide thorough coverage. When treating golf greens, always treat aprons and approaches as well to reduce the chance of carrying disease onto the green. Use 3-5 gallons of water per 1,000 square feet of treated area. Apply the higher recommended rates under severe disease pressure. Always calibrate sprayers prior to use, and maintain continuous agitation to keep the product in suspension.
